(CSK) is a 501(c)(3) nonprofit organization founded in 1977 to provide free, nutritious meals in a safe, welcoming environment to anyone in need, without qualification or cost. Operating from our central location in downtown New Haven and through a growing network of neighborhood-based meal sites, CSK served over 86,000 meals in 2024. In addition to daily meal service, CSK connects guests to essential wraparound services, including public showers, emergency clothing, and community health screenings. Through strategic partnerships and the ongoing expansion of our "Closing the Meal Gap" initiative, CSK is working to reduce food insecurity across New Haven by delivering meals directly to the neighborhoods most affected by poverty and hunger.
